APPLICABILITY:

1. Any customer taking service under the Industrial Power Service Rate Schedule pursuant to firm capacity contract between Company and customer. Service under this rate is special and Company will not be obligated to furnish such service unless it has sufficient electric capacity available to provide the amount of service required.
2. Service under this schedule shall be interruptible and Company can interrupt service under this schedule at any time without notice to customer if interruption is necessary to maintain the quality or quantity of power sales to firm customers or to protect the integrity or reliability of its system. In addition, where both firm power and economy power are taken through one delivery point and customer fails to reduce the economy power requested, Company may interrupt firm power service. The availability of this service is solely subject to the Company's ability to obtain and deliver the power and energy scheduled by the customer as provided in this Schedule.

TYPE OF SERVICE:

Three phase, 60-hertz service delivered at 69.0 KV or above, where customer furnishes, installs and maintains all transformers and distribution facilities. Company may at its option, meter service on the secondary side of the customer's transformers and adjust for transformer losses.

TERRITORY:

Applies to all service area of the Company in New Mexico.

MONTHLY RATE:

The monthly charge to the customer will be the Company's total delivered cost of the economy service scheduled plus:

TAX ADJUSTMENT:

Billings under this schedule may be increased by an amount equal to the sum of the taxes payable under the Gross Receipts, Franchise Fees and Compensating Tax Act and of all other taxes, fees, or charges (exclusive of ad valorem, state and federal income taxes) payable by the utility and levied or assessed by any governmental authority on the public

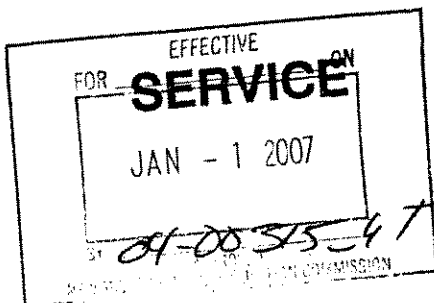
