APPLICABILITY:

Any municipalities or other governmental units for electric service where all service is taken through one meter at a single point of delivery and used for pumping required in the operation of water and sewage plants.

TYPE OF SERVICE:

Three phase, 60 hertz, 240, 480 volt service where the Company's facilities are of adequate capacity and the required phase and voltage are adjacent to the premises served. Service to motors of 50 HP capacity or less will be at 240 or 480 volts. Service to motors of more than 50 HP capacity will be at 240, 480 or 2,400 volts. All motors in excess of 40 HP must have Company approved reduced starting equipment installed by the customer. Where entire service cannot be measured at one utilization voltage with one standard type meter, it will be measured at primary voltage.

TERRITORY:

Applies to all service area of the Company in New Mexico.

MONTHLY RATE

Customer Charge per Month	\$6.83	
Energy Charge per kWh	\$0.08210	x
Demand Charge per Billing kW	\$15.36	

MINIMUM BILL:

The amount computed on the above monthly rate but not less than the sum of (a) \$15.36 per kW of billing demand established per the Determination of Demand below or \$35.00, whichever is greater and (b) the tax adjustments applicable to the current months use.

TAX ADJUSTMENT:

Billings under this schedule may be increased by an amount equal to the sum of the taxes payable under the Gross Receipts, Franchise Fees and Compensating Tax Act and of all other taxes, fees, or charges (exclusive of ad valorem, state and federal income taxes) payable by the utility and levied or assessed by any governmental authority on the public utility service rendered, or on the right or privilege of rendering the service, or on any object or event incidental to the rendition of the service.

DETERMINATION OF DEMAND:

For monthly billing purposes, including calculation of the minimum bill which shall be payable whether or not there is any demand established, kW billing demand each month shall be the kW supplied during the 15-minute period of Hours Of Optional Use as set out below, but not less than 60% of the highest billing demand established during the Hours of Optional Use in the 12 months ending with the current month.

HOURS OF OPTIONAL USE:

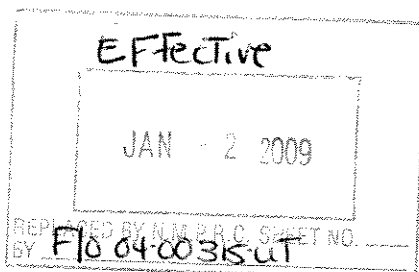
Initially the hours of optional use shall be from 12:00 noon until 8:00 p.m. each weekday during the calendar months of June, July, August and September of each year.


Hours of optional use are subject to change upon 12 months notification to customer.

Service under this schedule is available on an annual optional basis.

SPECIAL TERMS AND CONDITIONS:

This tariff schedule governs and supersedes all contracts or agreements between the Company and any of its customers served under this tariff schedule. Any service provided under this tariff schedule is further subject to the Company's rules and regulations on file with the New Mexico Public Regulation Commission. Controls for measuring the energy and power used during the hours of optional use shall be installed by Company, and customer shall pay the excess cost of such equipment above the cost of a standard meter installation. A contract for not less than one year must be executed by customer.
