PNM seeks proposals for new generation to serve New Mexico's energy needs

(Albuquerque, NM) – Public Service Company of New Mexico (PNM) is issuing a request for proposal (RFP) for any and all forms of electric generation and innovative technologies to power our customers and transition our energy mix to 100 percent emissions-free.

PNM is seeking up to 150 MW of accredited capacity energy resources, with an estimated in-service date of June 1, 2023.

The objective of PNM is to solicit competitive proposals for all forms of capacity, energy, demand response and storage resources that provide the best value to PNM customers, meet stringent reliability requirements and facilitate the continued transition toward an emissions-free future.

Putting New Mexicans first, PNM stated that they will give favorable consideration to bids that maximize the use of New Mexico workforce and apprentices.

The resources called for in the Request for Proposal (RFP) will allow PNM to maintain the required level of operating resources that meet industry mandates from the North American Electric Reliability Corporation and Western Electricity Coordinating Council.

Registration and Proposal Submittals

The RFP's event number is 100-GENALL-2020. Interested parties must access this RFP's event to download and submit an executed NDA required to receive access to the RFP's event package. The RFP's event package will be available on June 25, 2020.

In order to preserve transparency in the process and facilitate equal consideration to all respondents, bidders must not contact any PNM employees or agents of the company in regard to this RFP. All communications are to be conducted through PNM Sourcing public site. Attempts to communicate outside of the RFP website may result in a potential bidder being disqualified from participating in the RFP. PNM makes no commitment to respond to any other forms of communication.
