2	Q.	PLEASE STATE YOUR NAME, POSITION AND BUSINESS ADDRESS.
3	A.	My name is Leonard D. Sanchez. I am the Associate General Counsel for Public
4		Service Company of New Mexico ("PNM") and its affiliates. My address is 414
5		Silver Avenue, SW, Albuquerque, New Mexico 87102.
6		
7	Q.	PLEASE DESCRIBE YOUR EDUCATIONAL BACKGROUND AND
8		EXPERIENCE.
9	A.	PNM Exhibit LDS-1 is a summary of my educational background and experience.
10		
11	Q.	PLEASE DESCRIBE THE DUTIES AND RESPONSIBILITIES OF YOUR
12		CURRENT POSITION.
13	A.	I advise PNM and its affiliates on Securities and Exchange Commission
14		compliance and reporting and corporate governance issues. I also work or
15		financing and other commercial transactions. My administrative responsibilities
16		include supervision of in-house attorneys and staff, oversight of the Law
17		Department budget, including outside counsel expenses, and negotiation and
18		monitoring of retainers with outside counsel.
19		
20	Q.	WHAT IS THE PURPOSE OF YOUR TESTIMONY?
21	A.	I demonstrate that the litigation expenses PNM seeks to recover in this case are
22		prudent pursuant to NMSA 1978, Section 62-13-3 of the New Mexico Public

1		Utility Act (the "Act").	Specifically, I address the prudence of various categories
2		of litigation expenses	PNM incurred in the Base Period. These Base Period
3		expenses were escalated	d to arrive at the litigation expenses included in the Test
4		Period cost-of-service, a	as discussed by PNM Witness Monroy.

II.

2	Q.	WHAT TYPES OF LEGAL MATTERS CONSTITUTE "LITIGATION"
3		FOR PURPOSES OF YOUR TESTIMONY?
4	A.	Based on the definition in 17.9.530.7.P NMAC ("Rule 530.7.P"), "litigation"
5		includes all contested matters before regulatory commissions, administrative
6		bodies, arbitrators, and state and federal courts.
7		
8	Q.	WHY ARE LITIGATION EXPENSES ADDRESSED SEPARATELY
9		FROM OTHER LEGAL EXPENSES?
10	A.	The Act states that there is no presumption of prudence for litigation expenses and
11		both the Act and Rule 530.7.P require that the prudence of these expenses be
12		separately demonstrated.
13		
14	Q.	PLEASE DESCRIBE THE TYPES OF EXPENSES THAT COMPRISE
15		"LITIGATION EXPENSES".
16	A.	Litigation expenses are primarily legal fees associated with outside counsel and
17		their staff, and expenses associated with in-house lawyers and paralegals incurred

in connection with litigation as defined in Rule 530.7.P. Also included are matter

expenses, such as expert witness fees, court reporter expenses, court fees, and

1	Q.	PLEASE DESCRIBE THE CATEGORIES OF LITIGATION IN WHICH
2		PNM IS INVOLVED.
3	A.	PNM is routinely involved in the following categories of civil litigation: (1)
4		personal injury and property damage (referred to as "Tort Claims"); (2)
5		employment, labor and benefits, and workers' compensation (referred to as
6		"Human Resources Claims"); and (3) general civil litigation, including, but not
7		limited to, contract and environmental disputes (referred to as "Commercial
8		Litigation"). In addition, PNM is routinely involved in regulatory proceedings
9		before the Federal Energy Regulatory Commission and the New Mexico Public
10		Regulation Commission (referred to as "FERC matters" and "NMPRC matters,"
11		respectively). These are the types of litigation that PNM was involved in during
12		the Base Period and that are representative of the litigation matters in which PNM
13		is reasonably expected to be involved during the Test Period and beyond.
14		
15	Q.	WHAT MATTERS WERE ANALYZED TO DETERMINE THAT THE
16		LITIGATION EXPENSES ARE PRUDENT?
17	A.	Litigation expenses related to PNM's Tort Claims, Human Resources Claims,
18		Commercial Litigation, FERC matters, and NMPRC matters were reviewed. My
19		evaluation of the prudence of these expenses and a brief description of these
20		matters are summarized in my testimony and in PNM Exhibits LDS-2 through
21		LDS-6. These expenses were incurred during the Base Period (July 1, 2015
22		through June 30, 2016).

1	Q.	PLEASE EXPLAIN HOW PNM DETERMINED THE AMOUNT OF ITS
2		BASE PERIOD LITIGATION EXPENSES.
3	<b>A.</b>	The analysis involved a review of legal expenses incurred during the Base
4		Period. Consistent with Rule 530.7.P, however, only legal expenses related to
5		contested matters before regulatory commissions, other administrative bodies, and
6		state and federal courts (including arbitration matters) were included in Base
7		Period litigation expenses.
8		
9	Q.	PLEASE EXPLAIN WHAT LEGAL EXPENSES WERE NOT INCLUDED
10		IN THE BASE PERIOD EXPENSES.
11	A.	All legal expenses that were not allocated to PNM's retail electric business were
12		removed from the Base Period.
13		
14	Q.	ARE THERE OTHER LEGAL EXPENSES THAT YOU DO NOT
15		SEPARATELY ADDRESS THAT ARE ALSO INCLUDED IN THE BASE
16		AND TEST PERIODS?
17	A.	Yes. Non-litigation legal expenses for matters such as those relating to contract
18		negotiations and drafting, uncontested regulatory filings, and routine legal advice,
19		which are specifically not considered litigation expenses under Rule 530.7.P, are
20		also included in the Base Period and Test Period cost-of-service presented by
21		PNM Witness Monroy.
22		

1	Q.	HOW WERE LITIGATION EXPENSES ALLOCATED TO PNM'S
2		RETAIL ELECTRIC BUSINESS?
3	<b>A.</b>	Where a litigation matter was related to both New Mexico jurisdictional activities
4		and to other business activities, such as FERC-regulated activities, the expenses
5		were allocated using the methodology described in PNM Witness Monroy's direct
6		testimony.
7		
8	Q.	PLEASE DESCRIBE THE LITIGATION EXPENSES ASSOCIATED
9		WITH OUTSIDE COUNSEL.
10	A.	Generally, litigation expenses for outside counsel are comprised of the following:
11		1. fees based on hourly billing rates;
12		2. fees based on alternative billing arrangements, including retainers, with
13		various firms or on specific matters; and
14		3. expenses incurred by outside counsel in litigation matters.
15		
16	Q.	HOW DID YOU DETERMINE THE AMOUNT OF THE FEES
17		ATTRIBUTABLE TO LITIGATION WHEN A RETAINER WAS
18		INVOLVED?
19	A.	Outside counsel with retainers provide billing statements for each matter
20		reflecting fees for legal services of attorneys and paralegals charged on an hourly
21		basis and for associated costs. The fees attributable to litigation matters were
22		calculated using these notational billings and the outside counsel's billing rates
23		for PNM, as set forth in the retainer agreements.

#### 1 Q. HOW WERE INTERNAL LITIGATION EXPENSES DETERMINED?

- 2 A. In-house attorneys and paralegals track the amount of time they work on litigated
- matters through the Company's timekeeping system. This time was multiplied by
- 4 the employee's hourly compensation and charged to the specific litigation matter.

5

#### 6 Q. WHAT WAS THE AMOUNT OF LITIGATION EXPENSE IN THE BASE

#### 7 PERIOD THAT PNM USED TO PROJECT TEST PERIOD LITIGATION

#### 8 EXPENSES?

9 **A.** PNM incurred \$2,113,635 in litigation expenses as set forth in Table LDS-1 below.

#### III. PRUDENCE OF LITIGATION EXPENSES

#### 13 Q. HOW DID YOU DETERMINE THAT THE BASE PERIOD LITIGATION

#### 14 EXPENSES WERE PRUDENTLY INCURRED?

- 15 A. As an initial matter, I looked at the processes and mechanisms the PNM Law
- Department has developed to control litigation expenses. These processes and
- mechanisms are key to managing the litigation expenses and evaluating the

prudence of the expenses. The prudence of litigation expenses should not be determined solely by the nature of the claim or even the result of the litigation. Neither is it appropriate to trace every dollar spent to second-guess whether it was reasonably incurred. Further, I considered the litigation expenses in light of PNM's overall business operations and the business, legal and regulatory environments in which PNM operates. By New Mexico standards, PNM is a relatively large company doing business in an environment in which litigation is a frequently used method for resolving business disputes, and PNM is heavily regulated. PNM will be sued, and will bring suit, in the regular course of its business. Further, in the regular course of its business as a public utility, PNM will initiate, defend or intervene in proceedings before state and federal regulatory bodies. In all these matters, PNM must be represented by counsel.

## Q. WHAT GENERAL MEASURES HAS PNM TAKEN TO CONTROL

#### LITIGATION EXPENSES?

PNM has an internal Law Department with general responsibility for the legal affairs of PNM and its affiliates. The mission of the Law Department is to provide high quality, effective and efficient legal services to assist PNM in achieving its business goals. Qualified in-house counsel have been hired and have the responsibility to: (1) provide legal advice and representation; (2) select and manage cost-efficient qualified outside counsel as needed to represent PNM in its legal affairs and litigation; (3) oversee the substance of PNM's legal representation and litigation; (4) participate in strategic decisions in litigation; (5)

establish budgets for certain matters; and (6) control legal fees and costs in all legal matters. The Law Department frees non-lawyer management from the responsibility of overseeing and managing litigation. In seeking to control PNM's legal expenses, in-house counsel have aggressively negotiated reduced legal fees with outside counsel providing legal services to PNM. Outside counsel retainers are an example of alternative billing techniques designed to both control overall legal costs and provide a high level of certainty to PNM and its affiliates regarding their annual legal expenditures.

## Q. DID YOU CONSIDER ANYTHING ELSE IN EVALUATING

#### LITIGATION EXPENSES?

Yes. I considered several factors commonly used by New Mexico courts to determine whether the level of attorneys' fees incurred by a party to litigation is reasonable and prudent for purposes of an award of fees. These factors include the level of skill required, the nature and character of the controversy, the amount of damages claimed, the importance of the litigation, prevailing rates, and the benefits derived from the litigation. This list is not exhaustive and other considerations can come into play in any given case, including the importance of the litigation for precedential purposes. I have also applied my experience in managing legal costs and participating in various types of litigation in determining that the overall cost of litigation sought to be recovered in this case is prudent.

In evaluating litigation expenses in individual cases for prudence, I considered relevant factors and the circumstances of each matter in making my determination. No one factor is dispositive as litigation expenses reflect both events within PNM's control, as well as those outside its control. For instance, business objectives and precedential values may be of more importance than the financial exposure in a particular matter. Thus, different factors may be accorded different weight depending on the particular matter being evaluated. I have not described the details of settlements in the matters identified in my exhibits because: (1) a settlement may be subject to a court order of confidentiality or have confidentiality provisions as part of the settlement agreements; and (2) public disclosure of settlement amounts and methodology may harm the ability of PNM to aggressively negotiate settlements in future cases or may provide information that could be used to undermine its settlement strategy in pending or future matters. Finally, I reviewed the litigation expenses from previous years to ensure that the Base Period litigation expenses reflected the typical annual costs associated with

litigation, and were not unusually high or low. The Base Period litigation

expenses are, in fact, consistent with those from previous years.

1	Q.	IS THE LEVEL OF LITIGATION EXPENSES FOR WHICH PNM SEEKS
2		RECOVERY PRUDENT?
3	A.	Yes, it is, based on the general considerations described above and my review of
4		each category of litigation expenses relating to Tort Claims, Human Resources
5		Claims, FERC matters, NMPRC matters, and Commercial Litigation.
6		
7		Tort Claims involve property damage and personal injury claims filed by and
8		against PNM. For claims filed against PNM, PNM uses qualified defense counsel
9		experienced in personal injury and property damage litigation. For claims
10		asserted by PNM, PNM also contracts with commercial practitioners to collect
11		money from third parties who have damaged PNM's property or who owe PNM
12		money via a court judgment. These litigation expenses for collections are
13		necessary to reduce the overall costs of repairing and replacing PNM's property.
14		Please see PNM Exhibit LDS-2 for a summary of the issues, status and expenses
15		for the Base Period.
16		
17		In regard to Human Resources Claims, the Law Department uses attorneys who
18		have substantial expertise in employment law, labor relations, employment
19		benefits and workers' compensation claims to represent PNM in litigation. These
20		areas of law are complex and require attorneys who are experts in their field.
21		Please see PNM Exhibit LDS-3 for a summary of the issues, status and expenses
22		for the Base Period.

PNM is a FERC regulated electric utility and is subject to FERC's orders and investigations. FERC litigation expenses incurred by PNM are for specific cases where PNM is an applicant, a respondent, or an intervenor in a case where PNM's interest is directly affected. The Law Department retains counsel qualified in FERC law and procedures to represent PNM in these matters. FERC attorneys are in one of the most highly specialized practice areas in the country. Please see PNM Exhibit LDS-4 for a summary of the issues, status and expenses for the Base Period. As a provider of retail electric service in New Mexico, PNM is required by law to file with the NMPRC to obtain approval to engage in various activities related to its business operations. It must also respond to orders issued by the NMPRC. In some instances, it is necessary to intervene in proceedings that may set an important precedent applicable to PNM in future cases. PNM uses qualified counsel in state regulatory proceedings that have substantial experience with the laws administered by the NMPRC, and regulatory law in general, to represent PNM in NMPRC litigation. Please see PNM Exhibit LDS-5 for a summary of the issues, status and expenses for the Base Period. In the area of Commercial Litigation, the Law Department uses qualified litigators with expertise in commercial disputes, environmental matters, and other specialized areas as necessary. Please see PNM Exhibit LDS-6 for a summary of the issues, status and expenses for the Base Period.

#### 1 Q. ARE THE COSTS FOR NON-LAW DEPARTMENT PERSONNEL

#### INVOLVED IN LITIGATION MATTERS PRUDENT?

Yes. Although these costs are not included in the litigation expenses which are identified in my testimony, these labor costs for non-Law Department personnel are entirely reasonable and consistent with the demands of the individual cases. The issues involved in these cases tend to be complex and heavily contested. Given the significant impact on PNM's operations, PNM appropriately allocates internal resources to these proceedings. However, consistent with past interpretations of Section 62-13-3C of the Act and the additional time and resources involved, PNM has not attempted to comprehensively identify all inhouse labor involved in its litigation matters. As a practical matter, the resources allocated and the levels of effort expended on litigation matters, both in-house and externally, are reasonable and prudent. The responsibility of non-Law Department personnel for the management and oversight of litigation is reduced from what it otherwise would be due to the existence of the Law Department. Non-Law Department labor is utilized where necessary to properly handle litigation and, in some instances, replaces outside consulting services or outside counsel and paralegals where it is more cost effective and promotes more efficient and effective handling of the matter.

HOW DID PNM ESTIMATE ITS TEST PERIOD LITIGATION

Q.

2		EXPENSES?
3	A.	To arrive at an estimate of its Test Period litigation expenses, PNM first
4		identified the amount of internal and external fees and costs actually and
5		prudently expended for litigation matters during the Base Period. PNM then
6		applied the appropriate escalation to estimate its Test Period litigation expenses.
7		This is described in the direct testimony of PNM Witness Monroy. In my opinion,
8		the use of these escalators results in a reasonable representation of Test Year
9		litigation expenses.
10		
11	Q.	WHAT IS THE TOTAL AMOUNT OF TEST PERIOD LITIGATION
12		EXPENSE THAT PNM HAS INCLUDED IN THE COST OF SERVICE?
13	<b>A.</b>	PNM's Test Year cost of service on a total electric basis includes \$2,145,339 of
14		litigation expense.
15		
16	Q.	IS THE AMOUNT OF TEST PERIOD LITIGATION EXPENSE
17		INCLUDED IN THE COST OF SERVICE PRUDENT?
18	<b>A.</b>	Yes, it is. My opinion is based on the historic costs involved in litigation matters,
19		the cost-saving measures described above that PNM employs in engaging and
20		supervising outside counsel, the level of ongoing and anticipated litigation
21		activity, and anticipated increases in external and internal expenses. These factors
22		confirm my opinion that PNM's estimate of Test Period litigation expense is
23		reasonable and representative of the level of expense that PNM will incur when

1		new rates become effective, and that the amount expected to be spent on litigation
2		is prudent.
3		IV. CONCLUSION
4	Q.	DOES THIS CONCLUDE YOUR TESTIMONY?
5	A.	Yes it does.
