NOTICE OF PROCEEDING AND HEARING

NOTICE is hereby given of the following matters pertaining to the above-captioned case pending before the New Mexico Public Regulation Commission (NMPRC or Commission):

- 1. On June 17, 2022, Public Service Company of New Mexico (PNM or Company) filed an application requesting approval from the Commission for an order approving PNM's continued use of its fuel and purchased power cost adjustment clause (FPPCAC) under Rules 550.13, 550.14, 550.16, and 550.17 NMAC.
- 2. A FPPCAC automatically flows through to the users of electricity the increases or decreases in applicable fuel and purchased power costs.
- 3. Rule 550.17 NMAC requires each utility operating with a FPPCAC as part of its tariff to file an application for continued use of its FPPCAC at intervals of no more than four years.
- 4. PNM seeks to continue use of the quarterly factor adjustment, limitations on factor increase, treatment of off-system sales margins, and carrying charge on over- and under-collections approved in Case No. 13-00187-UT. Among the issues to be considered in this matter is whether the Commission should impose additional conditions on PNM's FPPCAC to ensure that it is consistent with the goals of the Public Utility Act, the Energy Transition Act, the Renewable Energy Act and related statutes, "including serving the goal of providing reasonable and proper service at fair, just and reasonable rates to all customer classes." 17.9.550.14 NMAC.
 - 5. The Commission is required by law to act promptly on PNM's application.
- 6. On October 26, 2022, the Commission entered an order designating Christopher P. Ryan as hearing examiner to preside over this proceeding and to issue a recommended decision.
- 7. Further information regarding this case can be obtained by contacting PNM or the Commission, as provided below. The Commission has assigned Case No. 22-00166-UT to this proceeding and all inquiries or written comments concerning this matter should refer to that case number.
 - 8. The present procedural schedule for this case is as follows:
 - a. On or before January 13, 2023, any person desiring to intervene to become a party (intervenor) in this case must file a motion for leave to intervene as required by NMPRC rules of procedure, 1.2.2.23(A), (B) NMAC.
 - Utility Division Staff (Staff) will, and any intervenor may, file direct testimony by March 3, 2023.
 - c. Rebuttal testimony must be filed by March 15, 2023.
 - d. A public hearing will be held beginning on April 24, 2023, commencing at 9:00 a.m. and will be conducted either through the Zoom videoconferencing platform or at the Commission's offices.
 - e. Whether the proceeding will be conducted remotely, live, or in some hybrid fashion will be determined as the hearing date nears.
- 9. Interested persons should contact the Commission for confirmation of the hearing date, time, and place since hearings are occasionally rescheduled.
- 10. The Commission's Rules of Procedure, 1.2.2 NMAC, applies in this case except as modified or varied by order of the Hearing Examiner or Commission. The rules of procedure and other NMPRC rules are available online at the New Mexico Compilation Commission at https://nmonesource.com/nmos/en/nav.do.
- 11. Additional details regarding this proceeding and its procedural requirements are set out in the Hearing Examiner's procedural order which was filed on November 4, 2022.

- 12. Any person whose testimony has been filed shall attend the hearing and submit to examination under oath.
- 13. Interested persons who are not affiliated with a party may make oral or written comments as provided by Rule 1.2.2.23(F) NMAC. Oral comment will be taken at the beginning of the public hearing in this matter on April 24, 2023. Each commenter will have three minutes to express their comments. If this proceeding is conducted via Zoom, public comment will also be taken through Zoom, and anyone wishing to make an oral comment must register to be admitted into the Zoom hearing in advance, not later than 8:30 a.m. MT on April 24, 2023, by e-mailing Ana Kippenbrock at **Ana.Kippenbrock@prc.nm.gov**. Written comments may be submitted before the Commission takes final action by sending the comment, which must reference NMPRC Case No. 22-00166-UT, to **prc.records@prc.nm.gov**. Public comments, whether oral or written, will not be considered as evidence in this proceeding.
