NOTICE OF HEARING

This matter comes before Hans Muller and Keven Gedko, hearing examiners for the New Mexico Public Regulation Commission, on *Public Service Company of New Mexico's Response* to Order Requiring Response ("PNM's Response") filed on December 11, 2023. The Hearing Examiners **FIND AND CONCLUDE** as follows:

A. The Hearing Examiners ordered Public Service Company of New Mexico ("PNM") to identify the availability of witnesses for a proposed limited hearing on either December 19 or 20, 2023.

B. PNM's Response indicates that their witnesses will be available on December 20,
2023 and asks the Hearing Examiners to consider presentation of the witnesses in a panel format.

C. The Hearing in this matter was previously noticed via the Procedural Order issued on August 4, 2023 and PNM provided Affirmation of Publication and Customer Mailing. All terms and conditions specified in the procedural order regarding the hearing remain in place.

D. A Second Notice of Proceeding was issued correcting the prior intervention deadline and set an intervention deadline of November 20, 2023. The intervention deadline passed without a party objecting or intervening in the matter.

2. The evidentiary hearing shall be conducted via the Zoom videoconference platform. Access to and participation in the evidentiary hearing shall be limited to party participants (i.e., counsel and witnesses), the Commissioners, and other essential Commission personnel. The Zoom hearing will be livestreamed through YouTube and will be displayed on the Commission's website at <u>https://www.nm-prc.org</u>. Persons not participating in the evidentiary hearing as an attorney or witness may view the hearing on the Commission's website and shall not join the hearing via Zoom except to provide oral comment as allowed below.

3. Interested persons who are not affiliated with a party may make written comment as allowed by Rule 1.2.2.23(F) NMAC. The Commission may also schedule one or more public comment hearings at a place and time to be determined in the Commission's discretion. However, as Rule 1.2.2.23(F) provides, "commenters are not parties and shall not have the right to introduce evidence, to examine or cross-examine witnesses, to receive copies of pleadings and documents, to appeal from any decisions or orders, or to otherwise participate in the proceeding other than making their comments."

4. PNM shall post on their website by December 13, 2023 a copy of this Notice to update the hearing date previously posted.
