**PNM REBATE: UP TO \$600 MAIL-IN REBATE ON REFRIGERATED AIR CONDITIONER AND HEAT PUMP SYSTEMS**

PNM Energy Conservation Measure Rebate Program: PNM residential customers are eligible to get up to \$600 back from PNM when they purchase and have a registered program contractor install an eligible CEE Tier 1, 2, or 3 refrigerated air conditioner or heat pump system (the "Energy Conservation Measure"). **This rebate is good for purchases/installations made January 1, 2018 through December 31, 2018 or while funds are available for this program.** To be eligible for this rebate, the refrigerated air conditioner or heat pump system must be installed by a registered program contractor included on the list found at PNM.com/coolrebate. Limit two (2) refrigerated air conditioner or heat pump system rebates per PNM residential electric customer account. PNM residential customers are also eligible for a \$50 rebate for any eligible ENERGY STAR smart thermostat installed by a registered program contractor at the same time as the installation of a qualified Tier 1, 2 or 3 refrigerated air conditioner or heat pump system. **Smart thermostats installed by the homeowner or on a stand alone basis are not eligible for this rebate.** Limit two (2) smart thermostat rebates per PNM residential electric customer account. By participating in this PNM rebate program, customers agree to and acknowledge the Rebate Program Disclaimer of Warranties and Waiver and Release of Liabilities, which can be viewed in full at PNM.com/coolrebate or by requesting a hard copy from PNM by calling (877) 883-1754. PLEASE NOTE: Manufacturer equipment model numbers on installation invoices must match model numbers listed on rebate form and on the AHRI certificate. PNM reserves the right to inspect all rebated products to verify compliance with program rules and the accuracy of project documentation. This may include post-installation inspections or participant interviews.

**Please Include:**

- 1 A copy of a recent PNM residential electric bill
- 2 Attach an invoice showing the installation address, date of purchase, price and quantity of system purchased and the qualified system manufacturer name and all relevant model numbers. This information must also be provided for any ENERGY STAR smart thermostat rebates submitted.
- 3 To be eligible for the mail-in rebate, units must be listed in the CEE Directory of Efficient Equipment, which is also known as the AHRI Directory, and can be accessed by visiting ceedirectory.org. A CEE Tier 1, 2 or 3 certificate number (aka AHRI certificate reference number) and copy of the printed certificate must also be submitted with your completed rebate form. All system components must be matched in the AHRI directory for rebates to be processed. For split systems, this would include the furnace or air handler.
- 4 Incomplete information will delay or disqualify your rebate. Allow 4-6 weeks for rebates to be processed.
