EXPLANATION OF RIDER: Pursuant to the terms of the Company's Rate 22, this Rider is established to provide a mechanism for the Company to recover Total Excess Costs incurred by PNM as a result of underground construction of a specific distribution project in the City of Rio Rancho that would normally be installed overhead by PNM. The project that would normally have been installed overhead by PNM that is covered by this Rider is:

Pachmann Distribution Feeders

This Rider consists of a fixed monthly charge by rate class that is applied to all applicable customers located within the city limits of Rio Rancho.

APPLICABILITY: This Rider shall be applicable to all PNM customers receiving electric service under rate schedules 1A, 1B, 2A, 2B, 3B, 3C, 4B, 10A, 10B, 11B, and 30B that are located within the city limits of Rio Rancho.

RIDER EXCESS COST CHARGES: The following fixed charges will appear as a line item addition on monthly electric bills for customers located within the city limits of Rio Rancho.

(The charges billed under this Rider are considered to be contributions in aid of construction as opposed to electric revenue, and are thus not subject to either Franchise fees or gross receipts taxes)

TERRITORY: All territory served by PNM within the city limits of Rio Rancho.

DURATION: The Rider will be in effect for three (3) billing months from the effective date of this Rider. x
